International Conference “General and applied phonetics: on the 100th anniversary of Prof. Lyubov V. Zlatoustova”

Dear Colleagues!

We are happy to announce a call for papers for the Conference on the 100th anniversary of Prof. Lyubov V. Zlatoustova. The Conference will be held **October 10 – 12, 2024** at Lomonosov Moscow State University, Faculty of Philology.

Topics of interest include, but are not limited to:

1. General Phonetics. Experimental Phonetics.

Phonetics of spontaneous speech. Segmental and suprasegmental phonetics. Prosody. Current phonetic evolving in Modern Russian. Development of methods of spoken language research: history and current state of the art.

2. Instrumental phonetic research on poetic speech and singing.

3. Corpus linguistics: Speech corpora and phonetic databases.

4. Sociophonetics.

5. Psycholinguistics of speaking.

Speech generation. Speech perception and comprehension. Speech and emotions. Psychological and psychophysiological characteristics of personality in speech. Normal vs pathology speech.

6. **Teaching Russian phonetics to a foreign-language audience.** Phonetic interference and foreign language accent.

7. **Forensic speech examination.** Current problems and challenges of forensic speech examination. Speaker recognition (identification and verification). Forensic analysis of digitized and synthesized speech.

8. **Phonetics in artificial intelligence systems.** Speech technologies. Systems of automatic speech recognition and synthesis. Voice keys. Sound editors as tools for speech analysis. Neural networks for phonetic research (neural network machine translation, etc.).

The conference will feature a **round-table discussion** on the following topic “**Prof. Lyubov V. Zlatoustova's contribution to the development of linguistics. Memories of colleagues and alumni**”.

Venue: Moscow, Lomonosov Moscow State University, Humanities I, Faculty of Philology (Moscow, Leninskie Gory, 1, pp. 51).

Dates: **10–12 October 2024.**

The conference will be held in the hybrid mode (both in-person and online).

Working languages: Russian, English.

All attendees will get certificates of participation.

Participation in the conference and publication of proceedings are free of charge. The Proceedings of the conference will be published in digital format.

The paper title and the abstract’s content should fit the scope of the Conference; otherwise, the Organizing Committee reserves the right to reject the submitted application.

After registration, the Organizing Committee will confirm receiving one’s application and send them notifications of paper acceptance.

The Organizing committee has the right to reject the articles which do not fit to the scope of conference.

The program will be sent to all Conference participants before the meeting.

Requirements for the articles

- length: 10000–12000 characters incl. spaces in MS Word; text formats – *.doc, *.docx (in Russian or English);
- Times New Roman, 14 pt, in tables 10–12 pt;
- line spacing: single;
- margins: 20 mm on all sides;
- paragraph indentation: 1,25 cm;
- no links;
- no hyphenation;
- no page numbers;
- alignment: justified on the width of the page.
- For an article in Russian: title of the paper, initials and surname of author (authors); affiliation, summary and keywords – in Russian and English.
- For an article in English: title of the paper, initials and surname of author (authors); affiliation, summary and keywords – in English.
- References: after the article itself, in alphabetical order in the language of the original article under the heading "References". References are formatted according to GOST 7.05-2008.

The file name should correspond to the surname and initials of the first author without spaces (e.g., ИВАНОВАИ; BergFT).

Figures, tables, and formulas are arranged as a separate file corresponding to the author's surname and initials (ИВАНОВБГ_1, ИВАНОВБГ_2 ... (n); BergFT_1, BergFT_2 ... (n), where "n" is the figures number. These files should be sent together

with the text of the article. The text of the article should contain references to the attached tables and illustrations.

It is preferable to use the Word formula editor with standard settings.

If characters not available in Times New Roman font (check it, please) are used, the original fonts should be sent with the text of the article as an attachment to the e-mail message (file «ИВАНОВВГ_font»).

Use italics and bold for **text highlighting**. Please avoid using underlining, capitalization, and spacing.

In-text references are given as follows: [ИВАНОВ 2000: 175: Thomson 2015: 16].

Article structure and rules of presentation of the main elements of materials for publication

1. Title in Russian (in TNR bold, capital letters; center alignment; 14 pt).
2. Skip one row.
3. Information about the author(s) in Russian (italics, right alignment; 12 pt):
 - full surname, first name, patronymic;
 - affiliation of the author(s); affiliation common for co-authors is indicated once (in Russian);
 - e-mail.
4. Skip one row.
5. Abstract (150-200 words) in Russian; 12 pt.
6. Key words (5-6 words) in Russian; 12 pt.
7. Skip one row.
8. Title in English (in TNR bold, capital letters; center alignment; 14 pt).
9. Information about the author(s) in English (italics, right alignment; 12 pt):
 - full surname, first name, patronymic;
 - affiliation of the author(s); affiliation common for co-authors is indicated once (in English).
10. Skip one row.
11. Abstract (150-200 words) in English; 12 pt.
12. Key words (5-6 words) in English; 12 pt.
13. Skip one row.
14. The text of the article could be in Russian or English. If text is in English, the title of the article, surname and initials of the author(s), affiliation, abstract and keywords are given in English only.
15. References (in alphabetical order, numbered, in the language of the article; 12 pt).
